## GRANT GUIDELINES

The Mapp Family Foundation is a non-profit charitable organization whose purpose is to make grants and distributions to tax-exempt applicants who currently have 501(c)3 status under the Internal Revenue Code and who are classified as "not a private foundation" as defined under Section 509(a) of the Internal Revenue Code. The Mapp Family Foundation also makes grants to governmental agencies. Grants are not made to individuals.

Grants are made only after written applications are completed on our application form and are received, reviewed and approved by our Board of Trustees.

In addition to the completed and signed application form, the following information is required:

- A copy of the most current Letter of Tax Exempt Status addressed to your organization and received from the United States Internal Revenue Service.
- A copy of the most current IRS Form 990 filed by your organization.
- A list of your officers and Board Members.
- A copy of the most current audit (last fiscal year) of your organization.
- A proposal summary consisting of not more than one page, describing the purpose of your organization and explaining why your organization is requesting this grant. ***Also included in this proposal summary should be a breakdown of how your organization proposes to spend this grant and what outcome your organization hopes to achieve. Please be specific.***
- Any additional materials your organization feels may supplement your proposal, if appropriate.
- If you received a grant from us last year, please include a brief (one page or less) summary of how your grant was used.
